This memorandum summarizes the initiatives, student achievements, and faculty activities of the Environment, Development & Justice Project in the 2012-2013 academic year.

#### Mission Statement

Founded in 2011, the Environment, Development & Justice Project (EDJP) of the Center for International Law and Justice (CILJ) at Florida A&M College of Law is a multi-faceted program to promote faculty and student engagement within and outside the law school community on pressing issues involving environmental regulation, the needs of developing countries and of minority and low-income populations, and how these two topics intersect in the domestic and international law fields in promoting justice for vulnerable populations while ensuring adequate protection of the natural environment.

The EDJP seeks to advance FAMU College of Law's overall mission of training minority students for the legal profession and, more particularly, to place FAMU graduates in careers in domestic and international environmental law field, areas in which there is significant historical under-representation for minorities.

# F. NOAA-ECSC Grant

- Profs. Abrams and Abate participated in drafting and implementing a multi-year grant received by FAMU's Environmental Cooperative Science Center (ECSC).
- In 2012-2013, the grant funded three COL research assistants in summer 2012 (splitting 40 hrs/wk) and three \$10,000 fellowships for COL students on ocean and coastal law issues in the Gulf of Mexico region.

These fellows are part of the NOAA Educational Partnership Program and emphasize educational outreach to communities that are traditionally underrepresented in the Science, Technology, Engineering, and Mathematics (STEM) workforce. Under this most recent renewal of the grant to FAMU, the focus has been expanded to include "Policy and Decision Tools," which includes the processes by which STEM research is integrated into ocean and coastal law governance. Professors Abrams and Abate supervise the NOAA-ECSC Fellows program.
