#### MISSION STATEMENT

To provide free legal services in civil matters of the highest quality to low income residents and the under served community in the Minth Judicial Circuit in the most beneficial, proficient and professional manner. 1

### THE CLINIC'S GOALS

The goals of the Homelessness and Legal Advocacy Clinic are to educate students in homelessness related issues, such as housing, public benefits, family law, and consumer law. It is also the Clinic's goal to instill in students a sense of compassion and responsibility in representing the interests of the under represented. The Clinic aspires to provide students with practical training in core legal skills and an understanding of the rules of professional responsibility.

# THE CLINIC'S STRUCTURE

In addition to interviewing clients at the Clinic's office, Clinic students interview homeless individuals at the Coalition for the Homeless, the Women's Residential Counseling Center (WRCC), and potential clients that contact the clinic. Under the supervision of clinical faculty, students assess problems presented by these individuals and determine which cases should be accepted by the Clinic. Students then counsel the clients, negotiate on their behalf and represent them in court when necessary.

The Homelessness and Legal Advocacy Clinic may be able to provide assistance with the following legal matters:
