Law Day at FAMU College of Law

The Fifth District Court of Appeal will hold a session at the Florida Agricultural and Mechanical University (FAMU) College of Law with Honorable Judges **James A. Edwards**, **Richard B. Orfinger** and **Vincent G. Torpy, Jr.** set to hear oral arguments on Tuesday, March 15, 2016, in the Ceremonial Moot Courtroom. The annual Law Day event marks the ninth year the Court will visit the FAMU College of Law to hear arguments.

The first of three oral arguments is scheduled to begin at 9:00 a.m. After hearing arguments from both parties, the Court will entertain questions from the gallery regarding the appellate process, organization of the appellate court, and matters of other general concern. In addition to asking questions of the judges, questions may be directed to the lawyers representing the parties. The Court will not answer questions regarding the substance of the appeal. The question and answer process will be repeated after each argument.
