



The Honorable Perker Meeks, Jr.

Judge Perker L. Meeks, Jr. was born the sixth child of a farming family in Tallahassee, Florida in August of 1943. His commitment to equal rights for all persons was forged in his youth. At the age of 16, Meeks and other African Americans sat on the pavement in the front of the local five and ten cents store in protest of its segregated lunch Local law enforcement counter. officers responded with physical force which resulted in a permanent scar on the back of his head. His later efforts on school campuses to dismantle racism resulted in civil rights litigation that went to the United States Supreme Court.

Meeks received his Juris Doctor from Florida A&M University (FAMU) College of Law in 1968 after an undergraduate tenure that included playing varsity basketball as captain and forward for the Rattlers, and earning his undergraduate degree in political science and history in 1965. He was admitted to the Florida

Bar in 1969 and the California Bar in 1971, distinguishing himself in the San Francisco Public Defender Office for seven years, trying hundreds of cases and serving as Head Trial Attorney. He was appointed to the San Francisco Municipal Court by Governor Edward G. Brown, Jr. on January 18, 1980 and was elevated to the rank of superior judge in 1998, serving with distinction as Assistant and Presiding Judge of the Municipal Court, receiving honors and recognition by the California Trial Lawyers Association, the Charles Houston Bar Association, the Asian American Bar Association, and the California Judges Association.



Meeks, who is the father of Perker L. Meeks, III and Alicia Meeks, has carried a passion for music and sports, particularly basketball, as evidenced in his Rattler days, and has served with the Jewish Community

Center's "San Francisco Fog", Huster and Schneider LLP, and the Charles Houston Bar Association's "Chocolate Bar", to name a few community teams. He has also served his community, volunteering many hours helping young people, serving on the Board of Directors of the San Francisco Pretrial Project, and the San Francisco General Hospital Volunteers, as Vice-President of the Archbishop Riordan Athletic Program and the Paradise Baptist Church County Jail Project, and teaching social studies and history at St. Michaels Catholic summer school program. Meeks retired from the bench in 2006.

Dr. Shawn Robinson

For some reason, things have always seemed to "add" up for Dr. Shawn H. **Robinson.** He has received numerous awards and honors throughout a career that included a constant pursuit of degrees. Among those awards are the Phi Theta Kappa Florida Region Distinguished Advisor Award (2002); the Robert Giles Phi Theta Kappa International Distinguished Advisor Award (2001); Phi Theta Kappa Professor of the Year (1997-98); Paragon Phi Theta Kappa International New Advisor Award (1998); three time selection to Who's Who Among America's College Teachers (1996, 2003, 2004) and twice selected among the top 100 Outstanding Black Americans in Central Florida by Alpha Kappa Alpha Sorority, Inc., (2000, 2002).



Robinson joined Hillsborough Community College (HCC) as President of the Ybor City Campus in September 2007. Prior to that he served 15 years at Valencia Community College (VCC) on its East Campus in various capacities (adjunct Mathematics Professor, tenured Mathematics Professor, LRC Director, Academic Assistant to the Provost, and Dean of Social Sciences and Physical Education. In addition to teaching Mathematics, Mathematics Education,

and Student Success classes, he served as Phi Theta Kappa advisor and Florida Phi Theta Kappa Webmaster.

Dr. Robinson holds a Bachelor of in Mathematics Science degree Education (1991), a Master of Education degree in Mathematics Education (1994), and a Doctor of Education degree in Curriculum and Instruction (1998) from the University of Central Florida. He completed a Juris Doctorate degree at Florida A&M University in December 2005. As a FAMU Law student, he was the recipient of the Percy R. Luney Spirit of Service Evening Student Award in 2003.

As president of HCC, Robinson leads nearly 12,000 students who attend classes on the 15-acre campus located in the heart of Ybor City's entertainment and historical district.

Robinson lives in Lakeland, midway between his family in Orlando and the HCC campus in the Tampa area.

At the start of the Fall 2008 semester, the Center for International Law and Justice (CILJ) opened on the third floor of the Law Library. Developed and directed by **Dr. Jeremy Levitt**, Associate Dean for International Programs and Distinguished Professor of International Law, the CILJ seeks to develop scholarly, educational, and practice-oriented activities, and

evolve into the nation's leading center of excellence in research, training and advocacy in the international and comparative law of developing nations.

Later in the Fall semester, the law school opened FAMU Café. Located in the student lounge area of the first floor, the kiosk-styled eatery features Panera Bread items, including wraps and salads; as well as home-cooked hot items, such as soups; and Starbucks coffee. Operated by Sodexo, the Café also offers soft drinks, health bars, and

snacks for students on the run. The Café is open from 8 a.m. to 8 p.m. when class is in session.

Next on the agenda is the College of Law Bookstore, which will open in January 2009. For the first time, law students will have an opportunity to purchase their books on site as well as to buy other materials and FAMU paraphernalia. The bookstore will be operated by Barnes & Noble and will be located on the first floor of the law school in the Legal Clinic.
